


This Variation Agreement Number 102, is dated as of the 26th day of June 2014 and made

Between:

Autoridad del Canal de Panama, Building 740, Corozal, Panama, Republic of Panama (hereinafter called the "Employer") on the one part,

and

Grupo Unidos por el Canal S.A., of Building 22B, Brujas Road, Cocoli, Panama, Republic of Panama, a corporation organised under the laws of the Republic of Panama, registered under microjacket number 682266, document number 1683284 of the Mercantile Section of the Public Registry Office of the Republic of Panama (hereinafter called the "Contractor" and together with the Employer, the "Parties") on the other part.

Whereas:

- a) The Employer and the Contractor are party to Contract CMC-221427 for the Design and Construction of the Third Set of Locks, dated August 11, 2009 (as the same has been or may be varied, amended, supplemented or otherwise modified (the "Contract").
- b) Following extensive negotiations, the Employer and the Contractor have entered into the MOU pursuant to which the Employer and the Contractor have agreed to certain matters with a view to facilitating completion of the Works but without prejudice to each Party's rights and remedies under the Contract or otherwise, and to use their respective good faith best efforts to negotiate and agree a variation agreement to the Contract and any additional definitive documentation by the Effective Date (as defined in the MOU and as extended from time to time by mutual agreement of the Parties).
- c) Pursuant to Variation Agreement No. 090 dated March 13, 2014, the Employer and the Contractor agreed to each contribute USD 100,000,000 to be applied for the payment of the Specified Expenditures to the identified recipients in Appendix 1 to Variation Agreement No. 090.
- d) The Contractor has informed the Employer through letter GUPC-IAE-2832 dated April 14, 2014 that adjustments are required to the payable amounts in Appendix 1 to Variation Agreement No. 090 as referred to in Sub Clause 14.2I [Advance Payment for Specified Expenditures] which are necessary to be introduced for reconciliation purposes, whilst retaining the same original recipients and the same total amount as set out in Appendix 1 originally attached to Variation Agreement No. 090.
- e) Accordingly, the Employer has responded through letter IAE-UPC-2076 dated May



22, 2014 indicating to the Contractor that the Employer will agree to such adjustments and the replacement of Appendix 1 to Variation Agreement No. 090 with a revised Appendix 1, subject to the parties agreeing a formal variation to reflect such revised arrangements.

- f) As a condition to the Employer permitting the amendments to the Contract referred to in sub-paragraph (d) above and the effectiveness of the amendments specified in this Variation Agreement No. 102, the Contractor shall provide the VO. No. 102 Bond Issuer Confirmation in the form set out in Appendix 2 to this Variation Agreement No. 102 no later than five (5) Business Days after the date of this Variation Agreement No. 102.
- g) Therefore, subject to the terms of this Variation Agreement No. 102, the Parties have agreed to a variation to the Contract as hereinafter stated, but not further or otherwise.

THE PARTIES HEREBY AGREE AS FOLLOWS:

The Employer and the Contractor agree to vary the Contract as follows:

1. In this Variation Agreement No. 102, the words and expressions shall have the same meanings as are respectively assigned to them in the Contract, save as amended below or as expressly stated.
2. It is agreed that this Variation Agreement No. 102 and the modifications contained herein are approved and dated in writing by the authorized representatives of the Contractor and the Employer and in doing so the Parties acknowledge and identify that this is done in accordance with Sub-Clause 1.16 [*Entire Agreement*] of the Contract.
3. This Variation Agreement No. 102 is without prejudice to the merits of any claims and defenses that either Party may have against the other relating to the Contract (as to which both Parties' positions are fully reserved) or otherwise. Both Parties continue to reserve all rights, remedies and defenses related hereto, as set forth at clause 9 of the MOU and clause 9 of the MOU is hereby incorporated by reference. Without prejudice to the generality of the foregoing, the Parties' rights, remedies and defenses with respect to delay-related issues are expressly reserved. The Contractor agrees and acknowledges that it shall not make any claims against the Employer arising directly out of this Variation Agreement No. 102.
4. Save in relation to breaches of, or failure by either Party to comply with, the terms of this Variation Agreement No. 102, the Parties agree that they shall have no claims for additional time or money or any other relief or entitlement of any kind as a direct consequence of this Variation Agreement No. 102.
5. Further, the Contractor's obligations as to the progress of the Works and to complete the Works and comply with the Contract remain in all respects unaffected.

and nothing within this Variation Agreement No. 102 is intended to be a waiver or relaxation of the Contractor's obligations under the Contract, save only as expressly stated herein and the Contract shall remain fully effective as varied herein and the Contract shall have effect as though the provisions contained in this Variation Agreement No. 102 had been originally contained in the Contract.

6. This Variation Agreement No. 102 shall be governed by the Laws of the Republic of Panama and is deemed to be incorporated into and form an integral part of the Contract.
7. The Parties agree to amend Sub-Clause 1.1 [*Definitions*] of the Contract as follows:

The Parties agree to add the following definitions to Sub-Clause 1.1.6 [*Other Definitions*] of the Contract (which shall be added in proper alphabetical order but without any number):

"Revised Appendix 1 to Variation Agreement No. 090" means the revised Appendix 1 to Variation Agreement No. 090 which is attached at Appendix 1 to Variation Agreement No. 102.

"Variation Agreement No. 102" means Variation Agreement Number 102, dated June 26, 2014 between the Employer and the Contractor.

"VO No. 102 Bond Issuer Confirmation" means a written confirmation (or rider, amendment or modification, as applicable), in the form set out in Appendix 2 to Variation Agreement No. 102 and otherwise acceptable to the Employer, from each of (i) the issuer of the Performance Bond, (ii) the issuer of the Payment Bond and (iii) the issuer of the Plant and Material Security.


8. Subject to paragraph 10 of this Variation Agreement No. 102, the Parties hereby agree to:
 - (a) delete in the definition of "**Specified Expenditures**" in Sub-Clause 1.1 [*Definitions*] all references to "Appendix 1 to Variation Agreement No. 090" and replace in each case with the words "Revised Appendix 1 to Variation Agreement No. 090"; and
 - (b) delete in sub-paragraph (e) of Sub-Clause 14.21 [*Advance Payment for Specified Expenditures*] all references to "Appendix 1 to Variation Agreement No. 090" and replace in each case with the words "Revised Appendix 1 to Variation Agreement No. 090".
9. Subject to paragraph 10 of this Variation Agreement No. 102, the Parties hereby agree to amend Variation Agreement No. 090 by deleting the reference in line 5 of paragraph (e) of Appendix 2 to Variation Agreement No. 090 to "Appendix 1" and replacing with the words "Revised Appendix 1 to Variation Agreement No. 090".



10. The Parties agree that the amendment of the Contract in accordance with paragraph 8 of this Variation Agreement No. 102 and the amendment of Variation Agreement No. 090 in accordance with paragraph 9 of this Variation Agreement No. 102 is subject to the Contractor delivering to the Employer no later than five (5) Business Days after the date of this Variation Agreement No. 102 the VO No. 102 Bond Issuer Confirmation, failing which the amendments set out in paragraphs 8 and 9 above shall be of no effect and void. For the avoidance of doubt, this paragraph 10 of Variation Agreement No. 102 is without prejudice to the Parties' other rights and remedies in the Contract including but not limited to the Employer's rights under sub-paragraph (h) of Sub-Clause 14.2I [Advance Payment for Specified Expenditures].
11. Each Party shall from time to time (at its own cost) do, perform, sign, execute and deliver all such acts, deeds, documents and things (or procure the doing, performance, signing, execution or delivery of them) to give full effect to this Variation Agreement No. 102 and secure the full benefit of the rights, powers and remedies conferred upon it in this Variation Agreement No. 102.


