This Variation Agreement Number 121 is dated as of the 13th day of November 2014 and made

Between: Autoridad del Canal de Panama, Building 740, Corozal, Panama, Republic of Panama (hereinafter called the "**Employer**") on the one part,

and

Grupo Unidos por el Canal, S.A., of Building 22B, Brujas Road, Cocoli, Panama, Republic of Panama, a corporation organized under the laws of the Republic of Panama, registered under microjacket number 682266, document number 1683284 of the Mercantile Section of the Public Registry Office of the Republic of Panama (hereinafter called the "**Contractor**" and together with Employer, the "**Parties**") on the other part.

Whereas:

- (a) The Employer and the Contractor are party to Contract CMC-221427 for the Design and Construction of the Third Set of Locks, dated August 11, 2009 (as the same has been or may be varied, amended, supplemented or otherwise modified (the **"Contract")**).
- (b) The Contractor:
 - a. By letter GUPC-IAE-3033 dated July 29, 2014 requested a reduction, from 6 to 4, of the number of copies to be submitted by the Contractor to the Employer's Representative pursuant to Paragraph 1.04 K of Section 01 33 00 [Submittal Procedures] of the Employer's Requirements as amended by Variation 27 in return for a monthly reduction in the Contract Price of \$983.55, since the Contractor was facing a situation whereby it was not able to maintain printing equipment, among other supplies.
 - b. Accordingly, the Employer, by letter IAE-UPC-2262 dated September 23, 2014 accepted the Contractor's proposal conditional on the agreement by the Parties to a Variation Agreement, with no time impact on the Locks Contract.
 - c. Therefore, subject to the terms of this Variation Agreement No. 121, the Parties have agreed to a variation of the Contract as hereinafter stated, but not further or otherwise.

THE PARTIES HEREBY AGREE AS FOLLOWS:

The Employer and the Contractor agree to vary the Contract as follows:

1. In this Variation Agreement No. 121 the words and expressions shall have the same meanings as are respectively assigned to them in the Contract, save as amended below or as expressly stated.

- 2. This Variation Agreement No. 121 and the modifications contained herein are approved and dated in writing by the authorized representatives of the Contractor and the Employer and in doing so the Parties acknowledge and identify that this is done in accordance with Sub-Clause 1.16 *[Entire Agreement]* of the Contract.
- 3. Volume II, Part 3, Section 01 33 00 [Submittal Procedures] (as amended by Variation No. 27) Paragraph 1.04.K, shall be deleted and replaced with the following:

"Unless otherwise specified, upon the release of the Contractor's Documents for construction, the Contractor shall provide 4 half size (Size C) copies to the Employer's Representative, for Employer use during the Works."

- 4. The reduction, from 6 to 4, in the number of copies to be submitted by the Contractor to the Employer's Representative is effective from July 21, 2014. As a result of this variation, a monthly credit of \$983.55 shall be included in all Monthly Applications for Payment issued by the Contractor, from the August 2014 Application on. It is agreed that Payment Certificates issued by the Employer without the above agreed credit may be corrected pursuant to Sub-Clause 14.6 of the Conditions of Contract.
- 5. There is no time impact to the Locks Contract as a consequence of this Variation.
- 6. All of the Contractor's other existing and ongoing obligations as to the progress of the Works remain unaffected.
- 7. The Parties agree that, save as expressly stated herein, the Contractor shall have no claims for additional time or money or any other relief or entitlement of any kind as a consequence of this Variation Agreement No. 121 or arising out of it or in any way in connection with it.

In Witness whereof the Parties hereto have caused this Variation Agreement No. 121 to be executed on the 13 day of November 2014, by their duly authorized representatives.
