"1. Treatment: Ducts shall be kept clean of concrete, dirt, and foreign substances during construction. Field cuts requiring tapers shall be made with proper tools and shall match factory tapers. After a duct line is completed, a standard flexible mandrel shall be used for cleaning followed by a brush with stiff bristles. Mandrels shall be at least 30 cm long and have diameters 6.4 mm less than the inside diameter of the duct being cleaned or the nearest lower commercial diameter. Pneumatic rodding may be used to draw in lead wires. A coupling recommended by the duct manufacturer shall be used whenever an existing duct is connected to a duct of different material or shape. Ducts shall be stored to avoid warping and deterioration, with their ends sufficiently plugged to prevent entry of any water or solid substances. Ducts shall be thoroughly cleaned before being laid. Plastic ducts shall be stored on a flat surface and protected from the direct rays of the sun." (RFV-262)

There shall be no cost or time impact to the Locks Contract as a direct consequence of this Variation. All of the Contractor's other existing and ongoing obligations as to the progress of the Works remain unaffected. The Parties agree that the Contractor shall have no claims for additional time or money or any other relief or entitlement of any kind as a consequence of this Variation Agreement No. 132 or arising out of it or in any way in connection with it.
