Before any work is started in the above areas:

- a development plan, which, at a minimum, should indicate all structures to be erected and include a grading and drainage plan, must be prepared and submitted to the Employer for review,
- the Contractor must clearly mark the limits of the two new areas and erect perimeter fences to ensure that all activities stay inside the above defined boundaries, and
- the Contractor must comply with the requirements established in the relevant Sections of the Employer's Requirements.

The Employer has received the Contractor's deposit of \$20,990.00 (Citibank's Deposit No. 0903) and therefore, will pay ANAM, the Ecological Indemnification fee and execute a reforestation program of 1.88 hectares during a period of five years (one initial year for the reforestation and four years for maintenance of the reforested areas). (*RFV 141*)

There is no time or cost impact to the Locks Contract as a consequence of this Variation.
